The secretary presented the cases as under:

Item No. 1**Case of M.Phil Scholars in Mathematics-M/S Muhammad Rashad, Amanullah and Amir Ali**

The board after detailed discussion approved the action taken by the Vice Chancellor. The board also authorized the Vice Chancellor to decide the date of declaration of result in consultation with the Controller of Examinations of following M.Phil scholars;

Item No. 2**Case of M.Phil Scholar in Management Studies- Mr. Alam Zeb**

The board approved course work, research topic & synopsis of Mr. Alamzeb, M.Phil scholar and also granted him extension in study period for two semesters on payment of usual tuition fee & other charges.

The board further observed that in the research topic a hyphen must be inserted between the words NON and MONETARY (i.e. NON-MONETARY).

Item No. 03**Case of M.Phil scholar in organic chemistry, Mr. Sher Ali Khan**

The Board after detailed discussion decided that Mr. Sher Ali Khan, M.Phil Scholar be shown/transferred in the Department of Chemistry instead the Department of Pharmacy and in the Degree "Environmental Chemistry" be shown as his field of specialization.

The Board confirmed the action taken by the Vice Chancellor and further accorded approval for;

1. Course work
2. Research topic and synopsis titled "**REMOVAL OF MANGANESE AND PHENOL FROM WATER WITH MODIFIED SULFLOWER STEM**"
3. Extension in study period for two semesters on payment of usual tuition fee and other charges etc.

Item No. 04**Proposed "University of Malakand MS/M.Phil/Ph.D Bye-Laws 2009 & Onwards**

The board after detailed discussion recommended the proposed "University of Malakand MS/M.Phil/Ph.D Bye-Laws 2009 and onwards" as per annexure. Proposed amendments / additions by the board have been inserted accordingly.

The board further decided that:

1. In future the transcript be issued to MS/M.Phil/Ph.D cases showing GPA & CGPA instead of marks obtained and the current transcripts be revised accordingly.
2. The proforma for each MS/M.Phil or Ph.D scholar be prepared like that of University of Peshawar and Degree whether MS/M.Phil or Ph.D should be mentioned in the proforma.
