N.B:The following guidelines should be followed before submission


1. A list of admitted students duly approved by the competent authority through Directorate of Admission must be attached with the registration forms(for students of Main and Sub Campus only)
2. Only eligible candidates shall be admitted in the relevant discipline.
3. All candidates are required to attach SSC, F.A/F.Sc, or equivalent certificates and DMC's, Migration Certificate, two 4x4 size recent photographs, a copy of National Identity Card and domicile certificate duly attested. The attestation officer must be the head/Incharge of the concerned department/College.
4. Fee once deposited is neither refundable nor adjustable in case if the candidate is otherwise eligible.
5. Incomplete/unsigned forms and forms without the prescribed fee receipt will not be entertained.
6. Registration fee shall be deposited in the National Bank of Pakistan University Campus Branch Account No. 1-4.
7. In case of affiliated College(s) Registration fee may also be deposited in any Branch of Allied Bank A/C No.004-01-167-0001-8
