It is therefore, requested to submit (**Session wise**) registration forms of all regular students, duly complete in all respects not later than the following schedule;



N.B: The following guidelines should be followed before submission


1. A list of admitted students duly approved by the competent authority through Directorate of Admission must be attached with the registration forms (for Campus students only)
2. Only eligible candidates shall be admitted in the relevant discipline.
3. All candidates are required to attach relevant documents i.e. SSC, F.A/F.Sc, B.A/B.Sc, M.A/M.Sc, MPhil or equivalent certificates and DMC's, two 4x4 size recent photographs, a copy of National Identity Card and domicile certificate duly attested. The attestation officer must be the head/incharge of the concerned department/College.
4. **Migration Certificate** will be required from fresh and migrated students along with receipt of Rs.1200/- on account of Registration Fee.
5. Fee once deposited is neither refundable nor adjustable in case if the candidate is otherwise eligible.
6. Incomplete/unsigned forms and forms without the prescribed fee receipt will not be entertained.
7. Registration fee shall be deposited in the National Bank of Pakistan University Campus Branch Account No. 1-4.
8. In case of affiliated College(s) Registration fee may also be deposited in any Branch of Allied Bank **A/C No.004-01-167-0001-8**
