I am directed to refer to your letter No. Academics- DHE / No.2069/ dated 29-06-2020 on the subject noted above and to say that a meeting held with the Advisor to Chief Minister for Higher Education Department, Khyber Pakhtunkhwa, the following decisions were made:-

- New Admissions will be done for Associate Degree Program and BS Programs instead of BA/BSc.
- Guidelines provided by Higher Education Commission Islamabad will be followed.
- Sample Semester guidelines developed by Peshawar University will be circulated to all Universities.
- Quality Assurance Cell, Khyber Pakhtunkhwa will work with HEART for developing training programs including online trainings, App based modules.
- Students completing BA/BSc programs will have a window for academic session in BS 5th Semester.
