While scrutinizing the file by office of the undersigned, it was found that the subject scholar is enrolled in PhD program violating the minimum criteria of Higher Education Commission (HEC) as he completed his MS without research in the subject of Computer Science (Minimum criteria of HEC is attached). The case was communicated to Dean of Information Technology whom responded vide para quoted as under:

“The scholar fulfills the minimum criterion of UOM. Therefore his case may be processed. In the new policy of HEC, BS graduates can also apply for PhD. This policy has been adopted by some universities and admissions to BS graduates have been awarded. Based on this argument we may consider the case for further processing.”

It is worth mentioning that as per section 3(ii) (a) of the University of Malakand MS/MPhil/PhD Byelaws 2013 and onward, minimum criteria for PhD admission is quoted as under:

“M.S./M.Phil (18 year education) or equivalent, with minimum CGPA 3.0 (in the semester system), or First Division (in the Annual System), in the relevant field from an HEC recognized university.”
